STUDENT / PARENT HANDBOOK: I have received a copy of the Student/Parent Handbook for the current school year and agree to abide by the rules and regulations as printed.

SCHOOL PROPERTY AGREEMENT: I agree to be held financially responsible for any and all school property lost or damaged by my child.

PERMISSION FOR STUDENT DRIVERS: I understand that should my child drive a vehicle to school, he/she is to adhere to the rules as stated in the Handbook. I understand that CCA is not responsible for any articles left in the vehicle or for any damages to the vehicle or its contents. I assume any and all liability for the vehicle and its contents. I also agree that the vehicle may be searched by school personnel at any time.

RIGHT TO SEARCH AGREEMENT: I hereby give permission for school personnel to search and/or seize any package, such as but not limited to backpacks, gym bags, purses, tote bags, band instrument cases, or any package capable of concealing evidence of violation of the law or rules of the school.

PERMISSION FOR FIELD TRIPS: I hereby grant permission for my child to participate in school-related field trip activities for the current school year. Parents will be notified of date and destination prior to the field trip taking place. Field trips resulting in an extension of the school day and/or distances beyond a seventy-five (75) mile radius will require additional parent permission on a trip-by-trip basis.

PERMISSION FOR PHOTOGRAPHY, VIDEO TAPING, AND MEDIA PUBLISHING: I hereby give permission for my child to be video taped, audio taped, and/or photographed for education and public relations purposes. I also give consent for the school to use my child's likeness and/or voice in promotional and/or advertising materials about CCA in newspapers, TV, radio, etc.

FINANCIAL RESPONSIBILITY: I understand that I am responsible for regular monthly tuition payments, paid by semester payments, or paid-in-full advance tuition payment. I also understand that overdue tuition balances will result in report cards being withheld at grading periods. I understand that a \$15 late fee will be added on the 21st day of the month. I further understand that should my child participate in the Extended Care program these charges are to be paid in full on a monthly basis and must be kept current in order for my child to continue to participate in the program. A late fee of \$15 will be added to my Extended Care balance after the 20th of the month and if the balance is not paid in full by the first of the following month, I understand that my child may not participate in the program until such time as the balance is paid in full.

FINANCIAL ASSISTANCE: I understand and agree that financial assistance in any form—such as but not limited to discounts, scholarships, and financial aid—is a blessing and that I am responsible for keeping the portion I owe CCA current each month. I also understand that if my account is habitually delinquent I may lose the financial assistance and become responsible for the full amount of tuition due.

DISCIPLINE POLICY: I understand and will abide by the Discipline Policy set forth by CCA as written in the Student/Parent Handbook, Section 5.0, which states that serious violations of school standards will result in the student visiting the school principal at which time appropriate action will be taken. An attempt to contact a parent will be made prior to disciplinary measures being administered. A variety of disciplinary measures may be administered depending upon the severity of the infraction as well as the frequency of infractions. I understand and give my consent to the following options, which may include but are not limited to, in-school detention, in-school suspension, community service, etc. I also understand that repeated disciplinary infractions or infractions resulting in suspension may result in my child not being allowed to participate in field trips and end-of-year trips and activities.
